

## **RESOLUTION 2024-02**

### **COSTS FOR ON-LOT SEWAGE SYSTEM FEES, ZONING PERMIT FEES, CODE ENFORCEMENT FEES, HEARING FEES, CONSULTANT FEES, PLAN REVIEW/SUBMITTAL FEES, STORM WATER MANAGEMENT FEES, AND OTHER MISCELLANEOUS FEES**

BE IT RESOLVED AND ENACTED, and the same is hereby resolved and enacted by the Board of Supervisors of Upper Leacock Township, approving the following fees to become effective immediately:

#### **“FEE SCHEDULE”**

##### **Sewage Fees\* (SEO):**

Permit Application Fee	\$100.00
Permit Design Review (Conventional System)	\$300.00
Permit Design Review (Alternate System)	\$500.00
On-lot Sewage Permit Inspection Fee	\$75.00 - Per Inspection
Percolation Test	\$350.00 - Per Site
Probe Test	\$85.00 - Per Test
DEP Module Review Application Fee	\$125.00
SEO Review Fee (per hour)	\$75.00
SEO Fee per hour	\$75.00

\*The Sewage Enforcement Officer (SEO) shall not charge the applicant any more than the above applicable fees. Once these fees are paid, the SEO will submit proof to the Township for reimbursement. If professional services (such as a soil scientist) are required, the cost of such services shall be the responsibility of the applicant. All fees shall be paid at the time of the issuance of the Sewage Permit.

##### **Zoning Fees:**

Commercial/Industrial Structure	\$ 0.45 per sq. ft. (minimum \$150.00)

Institutional Structure	\$ 0.25 per sq. ft. (minimum \$100.00)
Residential Structure (Including additions and accessory structures)	\$ 0.20 per sq. ft. (minimum \$25.00)
Zoning Fee for Projects Not Meeting Defined Construction Classification	1% of total cost of improvement (minimum \$25.00)
Echo Housing fee	\$200.00 Plus Professional and Administrative Costs
Zoning Certificate of Occupancy	\$50.00
Building Permit Certificate of Occupancy	\$80.00
Permit Extension (Request Prior to Expiration)	Original Permit Fee But Not to Exceed \$50.00
Deck and Patio/Fence Permit	\$50.00
Demolition Permit	\$50.00
Pool Permit – Above Ground Pool/Spa/Jacuzzi	\$50.00
Pool Permit – In Ground Pool	\$100.00
Sign Permit (Temporary and Permanent)	\$50.00

Additional Permit Fees: If the excavation for, the construction of, or erection of any building including accessory buildings, or the alteration of any building, or any use change, or structure that requires a permit begins before a permit is issued, the permit fee is double the original fee plus one hundred (\$100.00) dollars.

**Code Enforcement\*:**

Initial inspection, violation notice and report	\$ 85.00 per hour
Legal Expenses of Township and court costs (if non-compliance requires involvement by Township Solicitor)	Township-approved hourly rate

Upper Leacock Township has adopted the Uniform Construction Code, effective July 8, 2004 and utilizes the services of either Associated Building Inspections, Inc. or Code Administrators,

Inc., independent third party firms, to implement the Code for commercial inspections and residential inspections. Any building requiring a code inspection also incurs a \$4.50 fee which is distributed to the Commonwealth of Pennsylvania, Department of Community and Economic Development and an administrative fee equal to 10% of the building permit fee.

\* Appeals Under Local Agency Law – Every request for a hearing under the Local Agency Law, 2 Pa. C.S. 551 et seq., for which the Township has not established a specific fee by other resolution or ordinance shall be accompanied by a fee in the amount of \$500.00. A stenographic record of the proceedings shall be kept. The appearance fee for a stenographer shall be borne or reimbursed to the Township entirely by the person or entity requiring a hearing. The cost of the original transcript shall be paid by the Township if the transcript is ordered by the Township or shall be paid by the person or entity requesting such copy of copies. In all other cases, the party requesting the original transcript shall bear the cost thereof.
