UPPER LEACOCK TOWNSHIP LANCASTER COUNTY, PENNSYLVANIA ORDINANCE NO. 2018- 02

AN ORDINANCE AMENDING THE UPPER LEACOCK TOWNSHIP ZONING ORDINANCE BY REVISING SECTION 316 - OFF STREET PARKING

BE IT HEREBY ENACTED AND ORDAINED, and it is enacted and ordained by the authority of the Board of Supervisors of Upper Leacock Township, that the Upper Leacock Township Zoning Ordinance is hereby amended as follows:

WHEREAS, Upper Leacock enacted its official Zoning Ordinance on September 22, 2015; and

WHEREAS, the Board of Supervisors desires to revise the requirements for off-street parking for single-family dwellings; and

WHEREAS, the Board of Supervisors desires to require that all parking lots, garages and parking spaces have a paved surface;

NOW, THEREFORE, be it ordained and enacted that the following amendments be made to the Zoning Ordinance of Upper Leacock Township, Lancaster County, Pennsylvania:

1. <u>Section 316.C is amended as follows:</u>

Every single-family dwelling shall be required to provide at least two (2) off-street parking spaces that are each rectangular and a minimum of nine feet (9') wide and eighteen feet (18') long. All off-street parking shall be located on a paved or compacted stone surface. No vehicles shall be permitted to be parked on grass areas. Such spaces must be provided behind the street right-of-way line and may be within garages, carports, and/or driveways. Additional regulations pertaining to driveways are contained in Section 305 of this Article. The remaining regulations contained in this section do not apply to off-street parking facilities serving one (1) single-family dwelling.

2. Section 316.E is amended as follows:

All parking lots, parking garages **and parking spaces** shall be constructed and maintained with a paved surface, as defined herein.

3. Any Ordinance or any part thereof inconsistent herewith, and any amendments thereof, are hereby expressly repealed.
